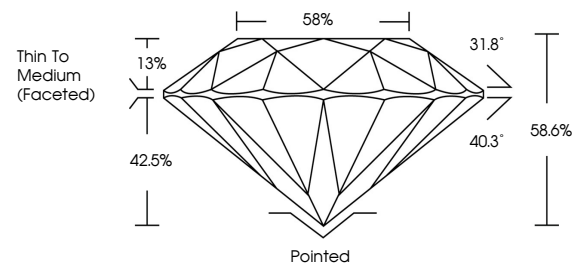

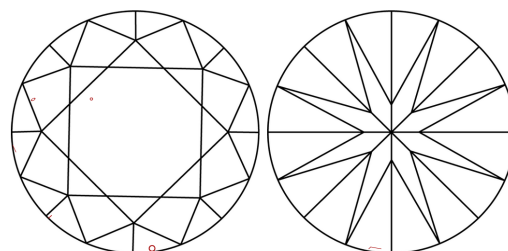

PROPORTIONS



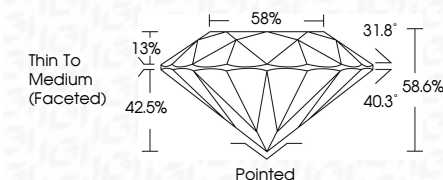
CLARITY CHARACTERISTICS
