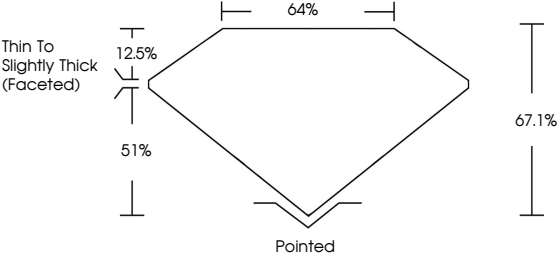

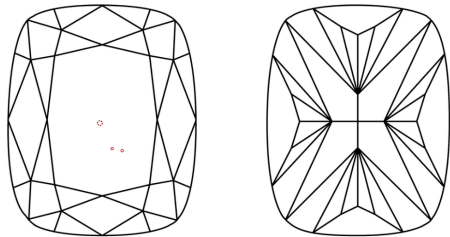

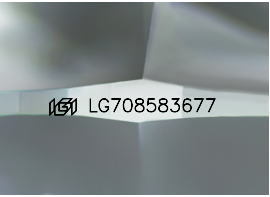
CLARITY CHARACTERISTICS
