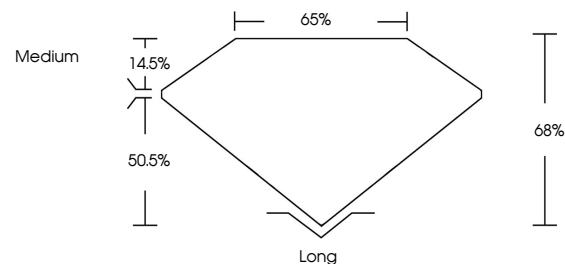

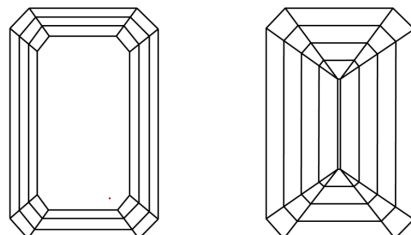

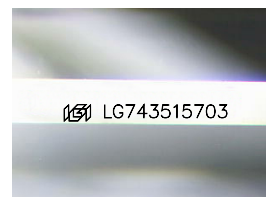


CLARITY CHARACTERISTICS

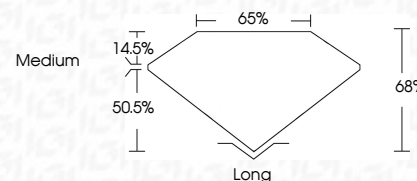
