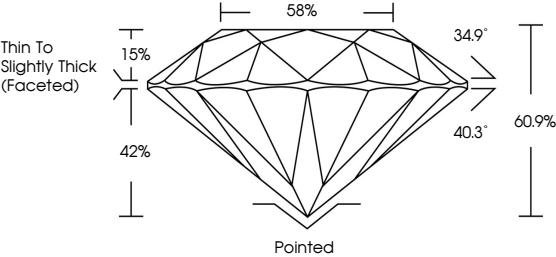

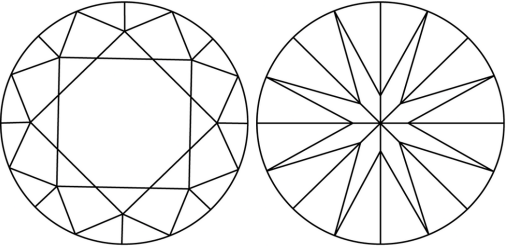

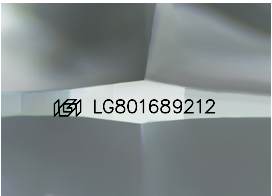


CLARITY CHARACTERISTICS
