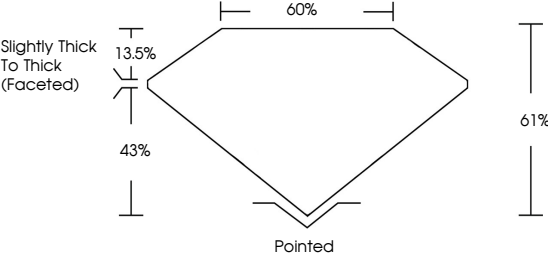

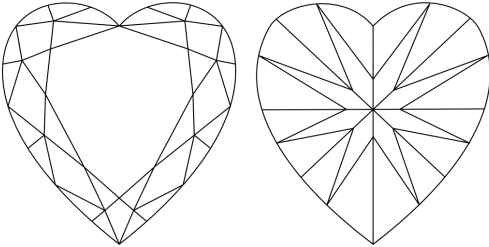

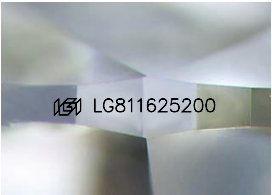


CLARITY CHARACTERISTICS
