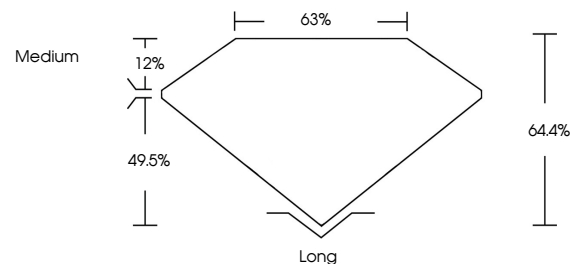

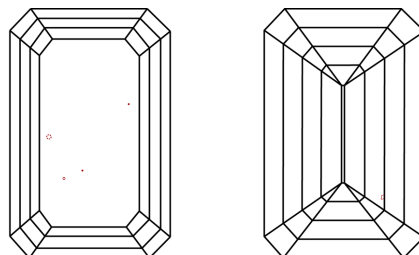

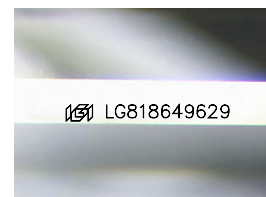


CLARITY CHARACTERISTICS

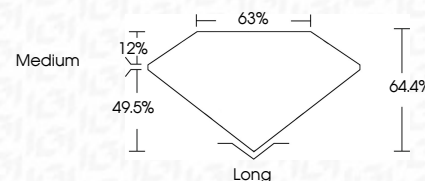
