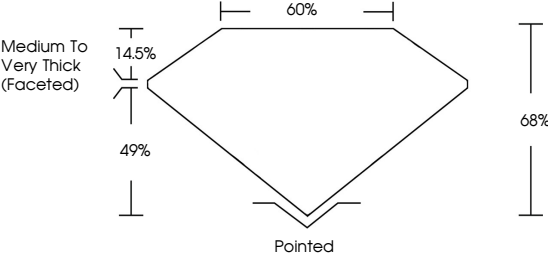

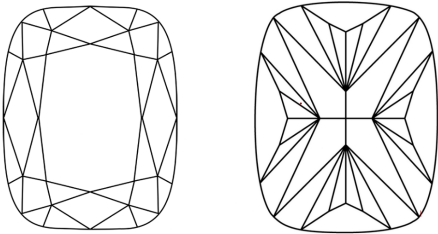

CLARITY CHARACTERISTICS

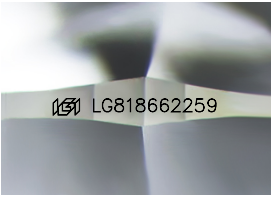
