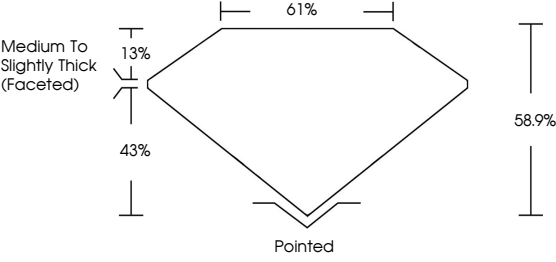

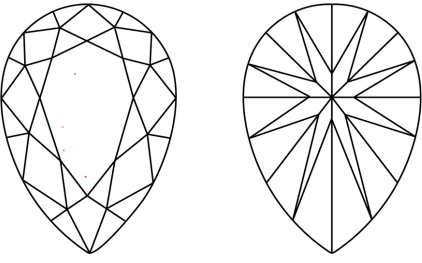

CLARITY CHARACTERISTICS



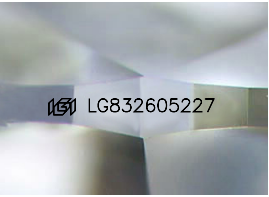
